2010 GRAIN POLICY FOR SHARE REQUIRED BUSHELS

Corn Shrink: 1.5 shrink per point of moisture over 15 %.

Delivery Requirement: 250 bu/ share

Corn Moisture: Moisture levels may be adjusted according to blending needs of the plant.

Wet	October/November	14.0-22.0%	22.1%
Modified Wet	January-March	14.0-19.0%	19.1%
Dry	April-September	14.0-17.0%	17.1%

Excess Moisture: Discount of 7 cents per point of moisture beyond rejection point. This will be discounted on a load-by-load basis.

Premium: Grain delivered within the Modified Wet & Dry Share program is eligible for 10 cent per bushel premium.

Damage: Maximum of 5%. Corn Over 5% damage is subject to rejection.

Discount 3 cents per pt 5-10%, 5 cents per pt over 10%

Musty: 7 cents per bushel.

Sour: 10 cents per bushel.

Weevily: 10 cents per bushel.

Moldy, sticks, stones, unknown foreign substances, rodent pellets, bird droppings or animal filth: Subject to rejection.

SELC will accept corn that test positive for aflatoxin up to 20 parts per billion.

SELC will reject any corn that tests above 20 parts per billion.

Corn delivered short of contract amount will be charged at the close of the day of delivery plus a 16 cent procurement fee. This amount will be deducted off the first contract payment.

Corn delivered in excess of the contract will be priced at the close of the day of delivery. Payment on those bushels will be included with the first contract payment unless other arrangements are made.

*** All corn must be delivered on a contract before payments can begin.**
